




Forthcoming decisions of the German Federal Government



Germany: Current scenario for RES capacity development by 2040

GVSt

- Current overall power generation capacity: 154 GW
- RES capacity extention to 120 GW by 2040
- Theoretically, almost no fossil or nuclear power plants needed anymore
- Risk of overcapacities: preference for RES feed-in?
- What will be the costs for this scenario, i.e. who will invest in production and transmission capacities
- Who will pay the electricity bill?



Unconventional gas: not enough bubbles to change Europe's indigenous fossil fuels play

- Tight gas
- Shale gas
- CBM Coal bed methane
- CMM Coal mine methane
- UCG Underground coal gasification

Shale gas: major prospective regions in Europe




Greenpeace Germany: New disinformation campaign on fossil fuels subsidies

- Headline “Hard coal funding seven times higher than stated by Government” for paper on public funding for coal and lignite
- Juggling with definitions of funding, R & D support and state aid
- Paper a “Triple use weapon”: contribution to public debate on (i) government spending cuts, (ii) future EU regulation on state aid to the coal industry and (iii) G20 initiative on fossil fuel subsidies?
- R & D for CCS described as “wrong subsidies”



Future EU-regulation on state aid to the coal industry: state of the play

- Council regulation 1407/2002 will expire on Dec 31st 2010
- COM impact assessment: new regulation beneficial for social and environmental reasons
- COM services divided on new proposal
- Time constraints: COM proposal needs to be adopted by Summer break
- Spanish approach via “Public Service obligation” an alternative?
- G20 initiative on fossil fuel subsidies wrongly interpreted

Future role of German social partners in the coal and energy sector

- Continuation of trustful co-operation as established during past 60 years
- Supporting “decarbonisation” of fossil energy use by reducing CO₂ footprint
- Giving critical advice to law makers through a holistic/ sustainable approach: reconciling social, economic and ecological aspects
- Sharing responsibility for development of coal regions
- Safeguarding and furthering competencies and skills along the entire fossil fuel value chain as macroeconomic assets
- United in their perception that coal will remain a strategic resource in Europe
